## Conditions of Membership

Subject to the By-laws of Anchor, each applicant for membership shall acknowledge that they subscribe to the following principles of 'Conditions of Membership':

1. We believe that it is both a privilege and a duty that the children of the Covenant be supported in accordance with Holy Scripture and to the honour and glory of the Covenant God.
2. We hereby acknowledge that the basis of Anchor is Holy Scripture, as confessed in the Three Forms of Unity: the Belgic Confession, the Heidelberg Catechism, and the Canons of Dort.
3. The principal purpose of Anchor is to promote the care and well-being of persons with disabilities to the best of Anchor's ability.
4. Individuals of 18 years or older are eligible for Anchor membership provided they are communicant members of a Canadian/American Reformed Church or a church belonging to a federation to which the Canadian/American Reformed Churches have ecclesiastical fellowship (as per the most recent Synod), which includes the United Reformed Church of North America and the Orthodox Presbyterian Church.
5. The annual dues will be determined by the Board of Directors and must be approved by the membership. Membership confers the privilege of voting at Anchor meetings as provided for in the By-laws and implies, as well, a readiness to participate in activities of Anchor.
6. Subject to the By-laws of Anchor, each member in good standing shall be entitled to one vote on each question arising at any special or general meeting of the members.
7. Husband and wife shall hold a single spousal membership.

## Termination of Membership

A person ceases to be a member in the following cases:

1. By giving written notice of resignation to head office,
2. When no longer a member of a church listed above, or
3. When membership fees are in arrears.
